## The Races

**OBS Sprint Stakes**  
**Filly Division - \$50,000 Guaranteed**  
Six Furlongs (Twenty Fourth Running)

**OBS Championship Stakes**  
**Filly Division - \$100,000 Guaranteed**  
One Mile and One-Sixteenth (Twenty Eighth Running)

**OBS Sprint Stakes**  
**Colt & Gelding Division - \$50,000 Guaranteed**  
Six Furlongs (Twenty Fourth Running)

**OBS Championship Stakes**  
**Colt & Gelding Division - \$100,000 Guaranteed**  
One Mile and One-Sixteenth (Twenty Eighth Running)

**PURSE DISTRIBUTION:** 1% to all horses finishing sixth through last, then remaining balance: 62% to the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. If less than five horses start, the purse that remains will be distributed to the winning horse.

At scratch time, the field for each race will be limited to fourteen (14) with preference given to those with the highest total earnings. Entry fee to be returned to excluded entrants. The races will be conducted according to Florida Statutes Chapter 550 as administered by the Division of Pari-Mutuel Wagering of the Department of Business and Professional Regulation. It is understood and agreed that the entries are accepted with the understanding that the horse so entered will only be allowed to start if in good standing at the time of the actual running of this event. **ALL STARTERS MUST BE LIP TATTOOED**

**Entry Date:** January 17, 2017

**OBS Championship Stakes:** \$1,000 to pass the entry box. \$1,000 to start.

**OBS Sprint Stakes:** \$500 to pass the entry box. \$500 to start.

**Though every effort has been made to notify the owner of due dates for pending sustaining payments, it will be the sole responsibility of the buyer or current owner to maintain eligibility**

## Eligibility

For Three-Year-Olds (foals of 2014) that have passed through an OBS Auction Ring.

### **SUSTAINING PAYMENT SCHEDULE:**

#### **First payment:**

\$100 due on or before September 1, 2016

#### **Second payment:**

\$250 due on or before December 1, 2016

**If the first sustaining payment was not made, a horse may be made eligible with a payment of:**

\$500 due on or before December 1, 2016

**IF SUSTAINING PAYMENTS ARE NOT MADE, HORSES MAY BE SUPPLEMENTED AT TIME OF ENTRY:**

OBS Championship Stakes: \$7,500 at time of entry, plus \$1,000 to start.

OBS Sprint Stakes: \$4,000 at time of entry, plus \$500 to start.
