TB Race 3 – Thoroughbred Starter Allowance – 3 Year Old Fillies

TB Race 4 – Thoroughbred Starter Allowance – 3 Year Olds

TB Race 5 – Thoroughbred Starter Allowance - Fillies and Mares

TB Race 6 – Thoroughbred Starter Allowance – 4 Year Olds and up

NOTE: Extra Races may be added on entry day but will only be used if the condition book races have less than six horses.

Races will be limited to eight (8) starters with four (4) also eligibles. Winners receive first preference over non-winners. Second preference will be given to those with the highest lifetime earnings. If the races overflow and multiple horses are entered that are owned wholly or in part by the same owner, and both horses would draw in based on the preference rule stated above, the trainer(s) shall designate which horse is preferred and the other horse will receive the least preference. All horses will race as separate wagering interests.

The races will be conducted according to Florida Statutes Chapter 550 as administered by the Division of Pari-Mutuel Wagering of the Department of Business and Professional Regulation. It is understood and agreed that the entries are accepted with the understanding that the horse so entered will only be allowed to start if in good standing at the time of the actual running of this event.

PURSE DISTRIBUTION

In all races the fifth through eighth place finishers will receive \$200. If the race has less than 8 horses, the balance of the purse available will be paid to the winning horse.

- **STABLING** - All horses must be stabled in the receiving barns at least four hours prior to first race post time. Stalls will be available prior to race day at no charge. Contact Harriet Booth at the OBS office for more information.
- **GATE CARDS/TIME WORKS** – There will be no fees for work and goes. Contact the OBS office for information.
- **LICENSING** - All owners, trainers, and racing personnel must be licensed and their fingerprints on file with the Florida Division of Pari-Mutuel Wagering. Only licensed personnel will be allowed in the receiving barn and restricted areas. PLEASE DISPLAY THE FLORIDA RACING LICENSE AT ALL TIMES WHILE IN RESTRICTED AREA (A TRACK BADGE IS NOT ACCEPTABLE).
- **STABLE PERSONNEL ROSTER** - Trainer's Stable Personnel Roster must be submitted to OBS office and posted in barn (DBPR PMW-3360 – see link below).
- **WORKERS' COMPENSATION INSURANCE** – A current policy must be on file with OBS prior to arrival indicating Florida coverage and OBS as a certificate holder. Contact Harriet Booth at OBS office for assistance.
- **JOCKEY CLUB or AQHA Registration Certificates** must be on file with OBS in order to race with AQHA transfers complete.
- **TATTOO/PARENTAGE VERIFIED** - All horses must be lip tattooed and AQHA parentage verified on papers.
- **COGGINS** – a negative Coggins Test dated within one year of race day must be on file at the OBS office.
- **HEALTH CERTIFICATE** – A Certificate of Veterinary Inspection dated within seventy two (72) hours of arrival must accompany any horse when shipped onto the OBS grounds and include the following statement:
 - “The horses listed on this Certificate of Veterinary Inspection have not originated from, nor been stabled on, premises which has had Herpes Virus Type 1 (EHV-1) diagnosed during the previous thirty (30) day period.”
- **THE FOLLOWING FORMS ARE AVAILABLE ONLINE AT OBSSALES.COM AND THE OBS OFFICE:**

 - **EHV-1** vaccination record (dated between 14 and 120 days from date of the race) must be submitted to OBS or stated on the health certificate.
 - **FUROSEMIDE (SALIX)** – An OBS designated veterinarian will administer race day Salix. A horse may be administered Salix no later than four (4) hours prior to scheduled post time. Trainers are responsible for having their representative present and available when the designated Veterinarian arrives to treat their horse. A fee of \$25 will be charged to the owner's horsemen's account. The Declaration to Administer or Discontinue Salix and Bleeder's Certificate Form must be on file at the Racing Secretary's office.
 - **MEDICATION** – Permitted medications for horses are to be administered per Florida Rule 61D-6.008.
 - **W-9 FORMS** – Owners and Jockeys must complete W-9 Forms prior to receiving payment from OBS.
 - **STABLE PERSONNEL ROSTER** – Must be filled out and posted in the stable area.
- **HORSESHOES** - A horse may not train or race with front shoes that have toe grabs which exceed 2mm, or bends, turn-downs, stickers, jar caulks or any other traction device. Turn-downs of more than ¼" will not be permitted on hind shoes. OBS recommends the use of only flat Queen's Plate, Queen's Plate XT or equivalent.
- **SAFETY VESTS AND HELMETS** - OBS requires ALL riders to wear an approved safety vest and helmet while on horseback. This applies to anyone aboard any horse (Ponies included). Safety vests must be zipped and helmet straps fastened at all times including to and from the racetrack and in the shed row.
- **PROHIBITED PRACTICES ON OBS GROUNDS:**
 - Extracorporeal Shock Wave Therapy or Radial Pulse Wave Therapy
 - Acupuncture and/or Electro-Stimulation with the intent of altering laryngeal function
 - Electrical devices designed or used to increase the speed of a horse
- **JOCKEYS** - All Jockeys must have ridden in one (1) or more Official Races during the seven (7) days prior to the races, or in five (5) or more Official Races in the sixty (60) days prior to the races, or in fifty (50) or more Official Races in the twelve (12) months prior to the races, or is an apprentice or foreign jockey riding in his or her first race.
- **TRACK HOURS** are 6:30 AM to 11:00 AM except 9:00 AM on Monday January 22nd due to the Under Tack Show.
- **DOGS** are not allowed on the grounds.
- **PURSES** will not be distributed until OBS receives blood and urine sample test results. OBS will withhold payment of purses to any owner for any horse which has suspicious or positive test results.
